Hazard Reduction & Recovery Center

The Hazard Reduction & Recovery Center (HRRC) was established within the College of Architecture at Texas A&M University in the fall of 1988. This report chronicles the activities and progress of the Center from that time until the present. In addition to the significant financial and organizational support provided by the College of Architecture, the HRRC also received valuable financial assistance from the Texas Engineering Experiment Station during its first two years.

At the time of its formation, the entire staff of the Center numbered four faculty members and two graduate students. Currently, there are 19 Faculty Fellows on the Texas A&M campus, five Associated Faculty Fellows at other universities, 17 graduate research assistants, and a support staff of four. Over 40 persons are currently associated with the HRRC.

Since 1988 a total of 53 different persons have been on the staff of the Center or in an Associate Faculty Fellow position. The researchers come from a variety of disciplines, including architecture, civil engineering, urban and regional planning, sociology, landscape architecture, geography, journalism, environmental psychology, construction science, environmental design, and policy analysis. The HRRC is now the largest multidisciplinary center studying natural and technological hazards and disasters in the world. Its staff of faculty researchers includes some of the leading experts on hazard mitigation, emergency planning and response, and disaster recovery in the United States. In recognition of these resources, the HRRC became a United Nations (DHA, formerly UNDRO) Collaborating Centre in June of 1990. It is one of only two United Nations Collaborating Centres in the world.

This report lists the accomplishments of the staff. It includes the work of the on-campus faculty and students at Texas A&M University and our Adjunct Faculty Fellows at other universities. However, the overview is limited

to only the hazard and disaster related material produced since the Center's inception. In total, researchers associated with the HRRC produced over 120 articles, books and monographs. They undertook research on 43 different research projects that generated over \$2 million in external funds. Representatives of the HRRC have attended over 100 conferences and workshops since its founding and have presented over 160 papers and lectures at these events and at other universities. Faculty Fellows served as consultants to about 40 public and private agencies, including the National Academy of Science, National Science Foundation, NASA, Lawrence Livermore Laboratory, National Institute of Building Sciences, the Federal Emergency Management Agency, and the States of Alabama and Texas. Representatives of the HRRC served on about 30 advisory panels and committees, including the American Institute of Architects, National Academy of Sciences, National Earthquake Hazards Reduction Program, National Science Foundation, United States Geological Survey, and the National Fire Academy. Personnel from the Center served as publication and proposal reviewers for about 80 different professional journals, publishers and funding agencies. Faculty researchers undertook research at 60 different domestic and foreign sites.

In addition to these research accomplishments, this report also discusses some other important activities of the HRRC, including its library, publication list, extension activities, and mass media contacts. All of the people associated with the Center wish to thank the College of Architecture, Texas Engineering Experiment Station, Texas Agricultural Extension Service, and Texas A&M University for their support and financial assistance in establishing the Center.

HRRC Library Development

The HRRC's library has expanded with regard both to space and holdings since 1989. In that year there were approximately 3000 items in the Center's holdings. The library lacked adequate shelf and work space. During 1991 the HRRC library was renovated and enlarged. The new facilities doubled the space within the Center. New shelving, furniture, work space and computer facilities were added. There are now approximately 13,000 items in the Center's holdings. Of these, about 3500 are catalogued electronically using the Sci-Mate software package. Also, the Center has access to a data bank of over 13,000 additional bibliographic sources. A complete set of United Nations publications is available.

HRRC Publication List

The HRRC established a Publication List in 1989. The original list included approximately 100 books, monographs, reports, articles and preliminary papers. The list currently includes 8 books and research monographs, 33 research reports, 104 published articles, and 28 preliminary papers. The material is available at minimal cost to interested members of the public, officials and other researchers. The Publication List has been widely distributed

throughout the world. Also, complete sets of HRRC publications are exchanged with the Disaster Research Center at the University of Delaware, the Natural Hazards Research and Applications Information Center at the University of Colorado, and the Department of Humanitarian Affairs of the United Nations in Geneva, Switzerland.

HRRC Extension Activities

In collaboration with the Texas Agricultural Extension Service (TAEX), the HRRC has developed an extension or information transfer program. This outreach program is unique among all disaster and hazard research centers in the United States. The program is under the direction of Dr. David Bilbo. The purpose of the program is to disseminate disaster and hazard research findings to individuals and organizations who can utilize the information.

During the past few years a number of workshops have been presented by the HRRC, including a workshop for Marine Extension Agents of TAEX in Houston, three workshops at the 1991 and 1992 Sooner Disaster College, a workshop at the National Emergency Training Center in Emmitsburg, Maryland, and presentations at the 1992 Regional Disaster Institute in San Antonio, Texas, the North Carolina Interagency Task Force on Family Protection, and the Natural Hazards Workshop in Boulder, Colorado. Dr. Bilbo has been appointed as an Adjunct Faculty member of the National Emergency Training Center in Maryland.

In addition, the USDA-HRRC-TAEX Joint Project entitled "Emergency Preparedness and Response Workbook for Extension Agents" was funded by the United State Department of Agriculture.

United Nations Department of Humanitarian Affairs Activities

In June of 1990 the HRRC became a United Nations (UNDRO) Collaborating Centre. As such, the HRRC became only the second UNDRO Collaborating Centre in the world, and the first in the western hemisphere. As part of this collaboration, the HRRC undertook extensive research in the Caribbean for UNDRO as it examined hurricane preparedness and response in the Leeward Islands. In addition, the HRRC held an international workshop on the

International Decade for Natural Disaster Reduction (IDNDR) at Texas A&M University. Furthermore, the HRRC has provided general consultation to the New York and Geneva offices of UNDRO and participated in UNIENET. With the reorganization of UNDRO into the Department of Humanitarian Affairs, discussions were held in Geneva on extending collaborative arrangements.
