### Summary of Competencies

Mr. McGinn has experience in the industrial construction and oil and gas industries that has spanned over the last 20 plus years in various construction management roles and construction experience in downstream and upstream functions. As a Construction Site Manager, Mr. McGinn is responsible for ensuring that all engineering deliverables are in line with construction needs as well as oversight and direction of all parties performing the construction installation activities in the safest, performance driven, schedule effective and cost-efficient methods.

Mr. McGinn is often assigned to projects in the earliest phases of engineering development and executes the project all the way through project completion and often commissioning activities as well. His role in both the home office and field execution environment is to help engineering, client, and craft personnel understand the construction path and objectives and priorities for both overall long range and day to day planning. He is responsible for chairing meetings to gain this alignment in small settings with upper level management but also mass meeting settings with all hands craft meetings where all site personnel are involved on a daily and weekly basis.

His past experience includes both home office engineering construction alignment / support and field installation execution in both the craft management (direct hire and CM) and technical service roles on many different projects. Mr. McGinn's focus through the years has been development of field procedures; execution strategies and construction indirect estimates for construction execution during the various engineering phases before mobilization to site; design constructability and construction planning; resolution of all engineering installation issues on-site; management of direct hire craft manpower (all crafts) along with management of subcontracts and subcontractor workforces; daily coordination meetings with plant operations to expedite work scope installation; systems turnover coordination and management including final sell-off of construction project systems, along with pre-commissioning and start-up / commissioning experience. All aspects of project experience from Mr. McGinn's past years of experience involve daily face to face instruction to all levels of the project organization to gain a common understanding. These interactions include one on one instruction and also group instruction to assure all involved parties understand actionable items and follow-through on activities being assigned.

Prior to starting his career in the construction industry, Mr. McGinn gained leadership experience in the United States Marine Corp as part of an infantry reserve weapons battalion. He also spent a number of years attaining oil and gas upstream industry experience working on an offshore jack-up drilling rig as a roughneck and construction coordinator on stacked rig revamp projects.
